- 1. Players from a team are wearing information about defensive shifts/offensive plays/and other game instructions on their belt. Is this legal? **Answer-NO**
- 2. The pitcher is wearing a wristband on the non-throwing arm with defensive/pitch information attached. The wristband is a single solid color, not distracting, and has a white card listing the pitch choices is this legal? **Answer- NO**. White card list needs to be cover by a flap or be a color other than white or gray.
- 3. Team A's catcher is struggling to understand signs from the dugout. He requests time and yells into the dugout, "Guys, you can't both keep sending signals!" You realize that both the head coach and assistant coach are using electronic devices to send signals to the catcher. Answer- This is illegal. Only one coach can have access to the device. The head coach should be warned that another violation will result in his ejection.
- **4.** Team A uses a one-way electronic communication device to communicate from the third-base coach's box to the batter. Is this legal? **Answer- NO. One-way communication is only from coach to catcher.**
- 5. Team A uses a one-way electronic communication device to communicate from the dugout to the pitcher. The plate umpire notices this and warns the head coach that this is illegal. Later in the game, the Team A pitching coach is seen in the dugout using the electronic communication device to communicate with the pitcher. Who is ejected? Answer- Head Coach and Pitching Coach are ejected.
- 6. Both teams are using a one-way electronic communication device to communicate from the dugout to the catcher for the purpose of calling pitches. Team A's communication device stops working in the second inning. Is Team B still allowed to continue using its electronic communication device? Answer-YES.
- 7. Team A's catcher is wearing a one-way electronic communication device on the wrist. In the sixth inning, the catcher notices it is not working. The catcher requests time and goes to the bench to quickly exchange the faulty wristband for that works correctly. Is this a defensive conference? **Answer-NO**
- **8.** Team A's catcher is wearing a one-way electronic communication device on the wrist. In the sixth inning, the catcher notices it is not working. Team A's coach requests time and it is granted. He then goes to the catcher near home-plate to fix the device. Is this a defensive conference? **Answer-YES**
- 9. With no outs and R1 on first base, B2 hits a hard ground ball to F6 playing directly behind second base. F6 fields the ball, steps on second base and throws to first in an attempt to double up B2. R1 is running standing up in a straight line to second base and is hit by F6's throw. R1 is about halfway to second base and did not intentionally interfere with the throw. Answer- This is not a violation of the force-play slide rule. R1 cannot be expected to slide at that point in the base path. The play stands. It would also be rare that a player let thrown ball hit himself. Most players will move or turn.
- 10. The umpire-in-chief may forfeit the game for infractions by spectators. Answer- False

- 1. R2 and no outs. B1 hits a single to right field. R2 rounds third base and comes home with the throw from the outfield being cut off by the first baseman. F2 was blocking the plate waiting for the ball. R2 intentionally lowers his shoulder to get through the catcher who is obstructing his path. **Answer-** This is obstruction but the obstruction is superseded by the malicious contact. The result is the run does not score, R2 is out and ejected.
- 2. B3 swears at F2. The umpire wants B3 removed from the game, but does not feel that he needs to be suspended for an ejection. Can he restrict B3 to the dugout for the remainder of the game? **Answer-NO**
- **3.** The defense gives up 8 runs in the top of the first. After the inning, the coach gathers his team together in front of the dugout and tells his players to "get [their] shit together." **Answer-** This is not allowed.
- **4.** F1 after striking out the side yells out a profanity at the opposing team. The plate umpire ejects F1. Is F1 allowed to remain in the dugout? **Answer-** Yes
- **5.** A freshman in the dugout of the hitting team is bench jockeying and making unsportsmanlike remarks. U1 sees the player making the remarks and ejects him. The freshman remains in the dugout and keeps making comments. What should the umpires do? **Answer-** Restrict his head coach to the dugout. If his head coach is already in the dugout, eject the head coach.
- **6.** The home team has installed a pitch clock for use during their games. They reference that the NFHS rules book establishes a 20-second time limit between pitches. Are they allowed to operate it during the game? **Answer-** No.

1.	The pitcher, with no runners on base, must pitch within seconds. Answer- 20 seconds.
2.	The pitcher, with runners on base, must pitch or make or attempt a play, including a legal feint, within seconds. Answer- 20 seconds
3.	NFHS Rules: With a runner on 1st base, F2 requests time and goes to the mound to speak with the pitcher. Is this a mound visit? Answer- No
4.	The coach of the defensive team moves to the pitcher's mound in the eight inning after having used three charged defensive conferences in the first seven innings. Does he have to pull his pitcher? Answer- No
5.	The coach of the defensive team has used one charged conference in the first seven innings. How many charged conferences does he have in the eighth inning where he will not have to pull his pitcher? Answer- 1
6.	With R3 on third base, and 1 out, B2 hits a fair ground ball to F3 who fields the ball beyond first base. He throws to F2, attempting to retire R3. The throw hits B2, who is running in fair territory and does not intentionally interfere with the ball. Answer- This is legal.
7.	With R3 on third base, B2 bunts a ball that is fielded by F2. F2 attempts to throw to F3, but because B2 is outside of the runner's lane and in the way, F2 tries to throw over B2's head. The throw goes 10 feet over the head of F3. Answer - This is interference, B2 is out and R3 is

8. B1 bunts a ball in front of home plate. F2 fields the ball and throws it to F3. The thrown ball hits B1 who is running in fair territory 30 ft. from home plate. **Answer-** This is legal.

returned to third base.

- **9.** B1 bunts a ball in front of home plate. F2 fields the ball and throws it to F3. The thrown ball hits B1 who is within 20 feet of first base with one foot in fair territory and one foot in foul territory. **Answer-** This is runner's lane interference.
- **10.** At the pregame conference, the coach of the home team is explaining the ground rules. He says that since they play on a turf field that has a grass infield, the runner's lane will be widened to include the "dirt" between the foul line and infield grass. **Answer-** This is illegal.
